Stuart L. Whitt, founding partner at Whitt Law, LLC, has represented school districts and other taxing bodies throughout Illinois since 1977. He has significant experience in all areas of school and municipal law.

PROFESSIONAL EXPERIENCE, Continued:

Mr. Whitt has successfully represented school districts and other local governments in a wide range of litigation matters, including the following:

- Successfully defended \$96 million of property taxes paid by Exelon Generation Company, LLC at the LaSalle Nuclear Power Station in LaSalle County, Illinois for tax years 2009 through 2012, resulting in a seven-year settlement agreement providing for the payment of \$153 million in additional taxes for years 2014 through 2019;
- Successfully defended \$27 million of property taxes paid by Exelon Generation Company, LLC at the Dresden Nuclear Power Station in Grundy County, Illinois for tax year 2012, resulting in a five-year settlement agreement providing for the payment of \$121 million in additional taxes for years 2013 through 2017;
- Successfully defended \$51 million of property taxes paid by Exelon Generation Company, LLC at the Braidwood Nuclear Power Station in Will County, Illinois for tax years 2011 and 2012, resulting in a seven-year settlement agreement providing for the payment of \$182.6 million in additional taxes for years 2014 through 2020;
- Successfully defended \$79 million of property taxes paid by PDV Citgo at the Lemont Refinery in Will County, Illinois for tax years 2009 through 2013, resulting in a five-year settlement agreement providing for approximately \$105 million in additional taxes for years 2014 through 2018;
- Successfully defended \$84 million of property taxes paid by WRB Refining, LP at the Wood River Refinery in Madison County, Illinois for tax years 2011 through 2013, resulting in a four-year settlement agreement providing for the payment of \$90 million in additional taxes for years 2014 through 2017;

- Successfully defended an elementary school district in an action filed by the company with the largest fleet of nuclear power stations in the country seeking approximately \$6 million in property tax refunds by obtaining a complete dismissal of all claims.

Mr. Whitt has also been instrumental in crafting unique and creative property tax incentives and intergovernmental cooperation agreements between cities and school districts to induce the construction and expansion of commercial and industrial properties within their jurisdictions, such as Aurora's Chicago Premium Outlets.

Mr. Whitt represents the Fair Assessment Information Resource Committee (FAIRCOM) which is a trust of local governments dedicated to the maintenance of fair and equitable assessments and taxation of electric generating stations throughout Illinois. In the Fall of 1997, the Illinois General Assembly enacted legislation providing for the deregulation of the electric utility industry within the State. Under Mr. Whitt's leadership, FAIRCOM was successful in securing legislation which assured continued financial stability for local taxing bodies and provided for the appointment of the State's Electric Utility Property Assessment Task Force of which he was a member. Mr. Whitt recently served as a member of the General Assembly's Property Tax Reform and Relief Task Force.
